technical development vs. judiciary

- proactivity
- courage

I. Legal background of the courts' relationship with the media (1)

- fundamental rights of freedom of information and protection on personal data
 - legal acts (Constitution, procedural codes, etc.)
- publicity of trials and court decisions - constitutional guarantee
 - exceptions! (public order, morality, classified info, private life..etc.), but! final decision is always public

I. Legal background of the courts' relationship with the media (2)

- legal acts - framework of the cooperation
e.g. individual cooperation agreements

but! proactivity might be risky....

II. Modern tools of communication: spokespersons, website, social media (1)

II.1. Role of spokespersons (1)

- at residences of courts
 - PR experts, assigned competent judges, spokespersons, press secretaries — huge responsibility in the evaluation of the judiciary
 - communication trainings
 - exclusive competence in informing the public
- >>> judges - express opinion only via judgements

II. Modern tools of communication: spokespersons, website, social media (2)

II.1. Role of spokespersons (2)

- keep in close touch with judges (contingent media attention...)
- to correct when false info disclosed:
 - press release
 - denial / objection
 - direct contact with journalists

II. Modern tools of communication: spokespersons, website, social media (3)

II.1. Role of spokespersons (3)

- A. trained communication specialist
- B. member of the organisation with legal qualification

KEY: 1. well organised internal communication
2. centralisation

II. Modern tools of communication: spokespersons, website, social media (4)

II.2. Websites

- importance of update
- webpages per court —one central website

II. Modern tools of communication: spokespersons, website, social media (5)

II.3. Courts in the social media

- only few countries use, but! appearance approved
pros: swift & reaches youngsters «» cons: comments
- appearance of judges
